### **Holdings in focus**

**Skipper** is one of India's largest transmission tower manufacturers. Due to its backwardly integrated operations, it's a low cost producer globally. Between FY19 and FY22 revenue growth slowed following India's banking crisis, which was further compounded by rising raw material prices. Skipper used this period to consolidate its operations, renewing its focus on cash flows and profitability, whilst adding to product certifications globally. The business is now recovering both domestically and overseas where growth is being driven by international customers looking to de-risk their supply chain from a dependence on China. In FY 22 exports formed approx. 45% this is expected to grow beyond 50% next year. We forecast margins to strengthen as raw-material prices stabilise and volatility in global freight costs are now absorbed by the customer, a further indication of strong demand. The company's recently seeded polymer pipes business has now achieved sufficient scale to be break even and is expected to contribute to Skipper's overall growth as the company penetrates new markets. We project a 19% CAGR in revenues and 135% CAGR in profits in during FY22-24.

Kajaria Ceramics is the market leader in ceramic and vitrified tiles in India. Having built a strong brand Kajaria is a price leader, enjoying a superior product portfolio and a strong distribution network, leading to better profitability (18-20% operating margins) and higher return rations (ROCE of 21%) than its main rivals. The business is now entering a high growth phase driven by a turn-around in the real estate sector, as well as a strengthening of its distribution network across smaller cities and towns, further increasing market share particularly as the competitive environment is improving. This is a consequence of many of the smaller players are diverting capacity to overseas customers, where tile distributors (particularly in the Unites States) are shifting away from over dependence on China. A better pricing environment is also helping it to pass on higher input costs, notably gas. Kajaria is expanding capacity in anticipation of volume growth at 15% p.a. over the next few years. Earnings growth is expected to be 22% per annum (next two years) driving return on capital employed (ROCE) to almost 30% over this period.

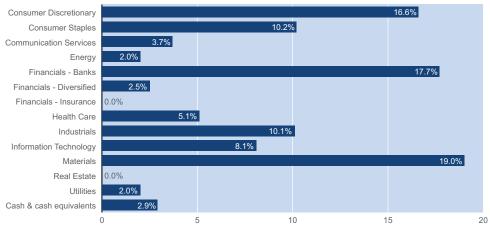

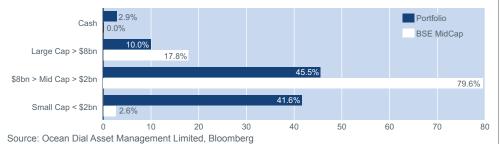
